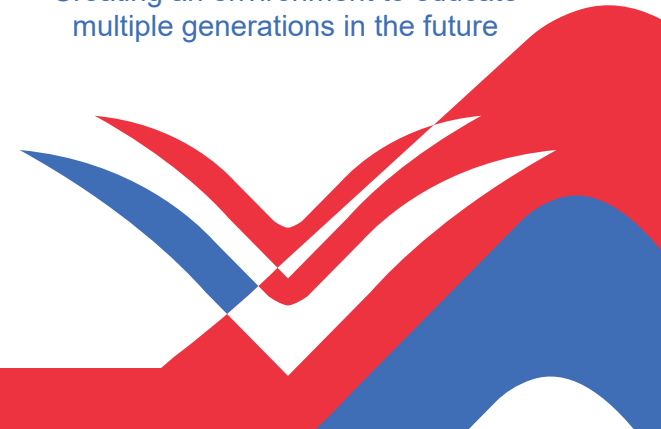


Kamoa Copper S.A. supports a facility of higher education, the Kamoia Centre of Excellence (KCE). The KCE is located between the Kamoia-Kakula operations and the town of Kolwezi, on the DRC Copperbelt. The KCE opened its doors to its first student intake in September 2023.

The curriculum, created in partnership with Enterprises University of Pretoria, offers students a one-year program covering modules in English Foreign Language (EFL), computational thinking, creative problem solving, basic financial literacy, workplace ethics, introduction to mining, project management, and entrepreneurship development. The classes are presented with a blended learning model, incorporating intermittent, face-to-face sessions and “online/virtual” sessions, presented at the KCE campus.

WHO CAN APPLY?

1. A minimum academic average result of 60% is required as shown by a grade 12 (4eme) report. (Current grade 12 students must submit their most recent report.)
2. Age group 18-25 years of age.
3. Applicants must have basic skills in English communication and computer literacy.
4. The applicant must be a citizen of the DRC.

HOW TO APPLY:

Send the following required supporting documents via email to the KCE Team at: info@kamoace.com:

1. A copy of your DRC identity card/document.
2. Your most recent academic transcripts/reports. Grade 12 (4eme) report.
3. A motivation letter in English of maximum 500 words.

Applications close on 3 March 2024.

SCREENING PROCESS:

1. Applications will be screened and shortlisted considering the qualifying criteria listed. (Refer: Who can apply?).
2. Shortlisted applicants will be required to undergo an admissions test, other assessments and attend a virtual/in-person interview.
3. On completion of screening process, admissions and bursaries will be awarded at the sole discretion of the KCE.
4. Incomplete and late bursary applications will be rejected.
5. Program commences in September 2024 and ends July 2025.

CERTIFICATION:

University of Pretoria certificates will be issued on successful completion of the one-year program.

BURSARY:

Includes tuition fees, course material, certificates, bus transport between the KCE, Kolwezi, and Kamoa surrounds, access to a laptop as well as a monthly student stipend. (Excludes accommodation.)
